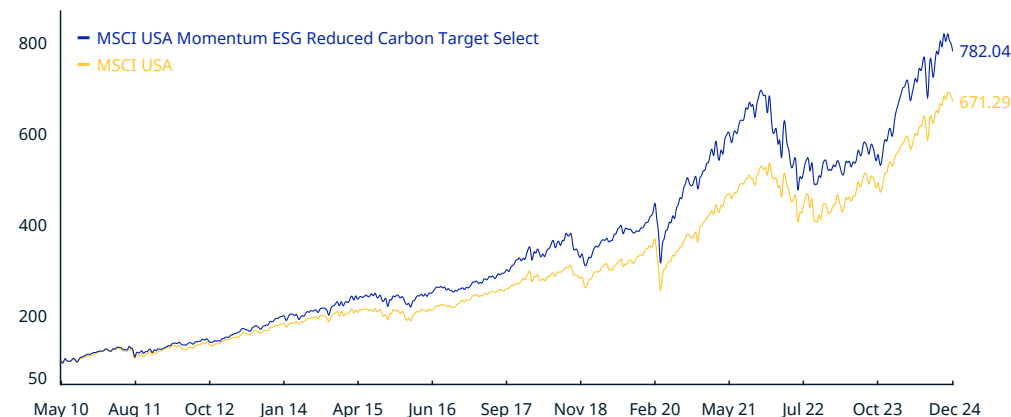


MSCI USA Momentum ESG Reduced Carbon Target Select Index (USD)

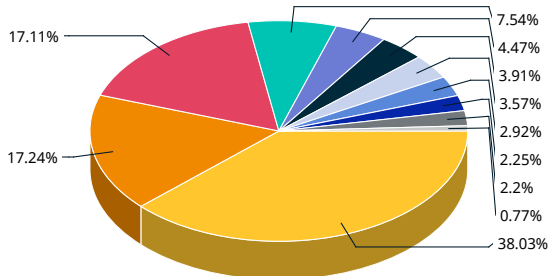
