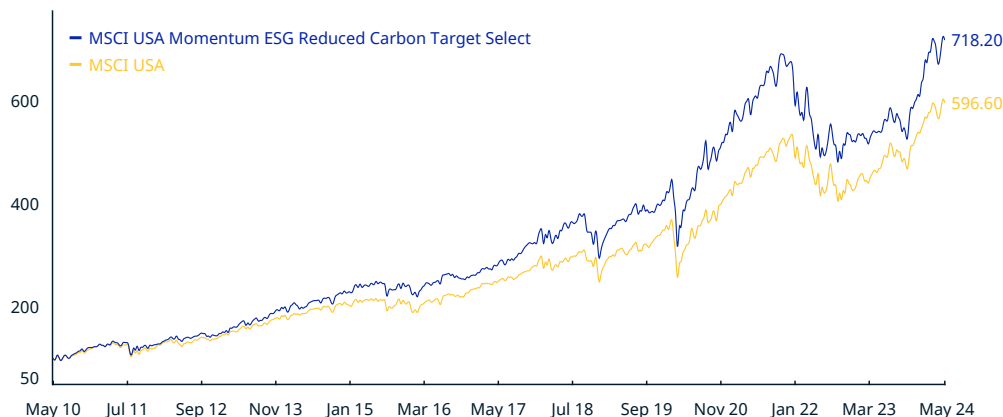


MSCI USA Momentum ESG Reduced Carbon Target Select Index (USD)

The index is designed to represent the performance of a strategy that seeks systematic integration of environmental, social and governance (ESG) norms along with the exposure to a momentum factor.

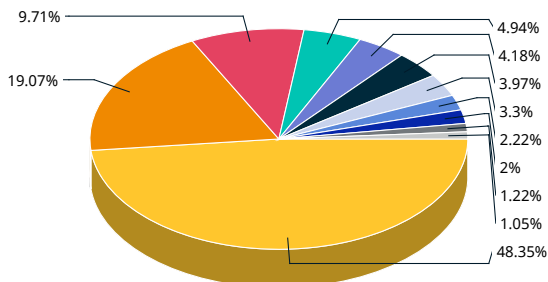
