

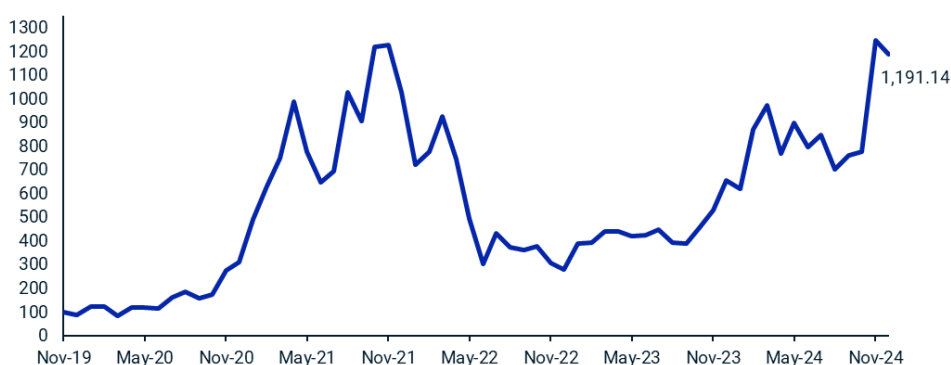
MSCI Global Digital Assets Select Top 20 Capped Index

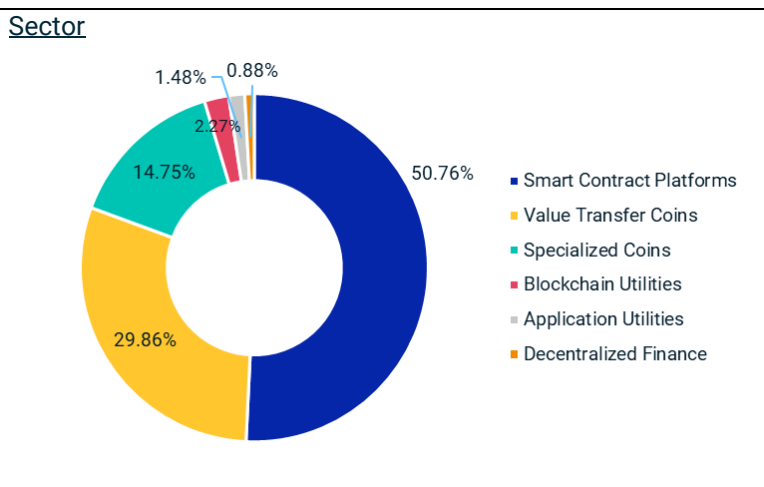
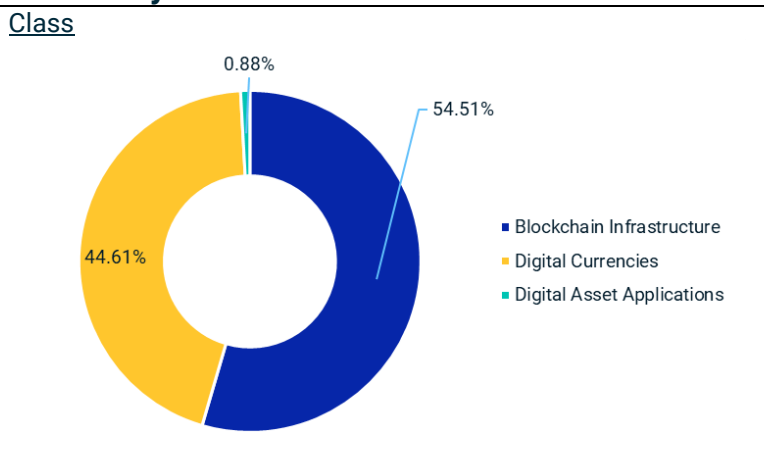
