


MSCI Australia Listed 300 - REITs Subset Index (AUD)

All securities in the Index are classified in the Equity Real Estate Investment Trusts (REITs) and Mortgage Real Estate Investment Trusts (REITs) according to the Global Industry Classification Standard (GICS®).


