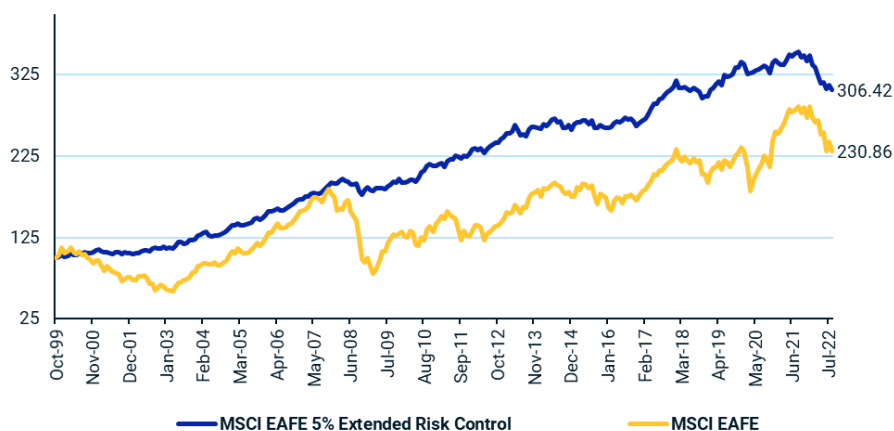


# MSCI EAFE 5% Extended Risk Control Index
