

# MSCI Mexico IMI 25/50 US Dollar Hedged Index (USD)

The **MSCI Mexico IMI 25/50 US Dollar Hedged Index** represents a close estimation of the performance that can be achieved by hedging the currency exposure of its parent index, the MSCI Mexico IMI 25/50 Index, to the USD, or the "home" currency for the hedged index. The index is 100% hedged to the USD by selling the MXN forward at the one-month Forward rate. The parent index is composed of large, mid and small cap stocks. It applies certain investment limits that are imposed on regulated investment companies, or RICs, under the current US Internal Revenue Code.
