

MSCI Australia Listed 200 Index (AUD)

The MSCI Australia Listed 200 Index (the "Index") is constructed from an index (the "Parent Index") which is a domestic free float adjusted market capitalization weighted index based on a combined universe of the MSCI Australian Shares All Cap Index and eligible foreign incorporated entities listed on Australian Securities Exchange (ASX). The Index aims to reflect the performance of the largest 200 securities of the Parent Index based on their market capitalization.

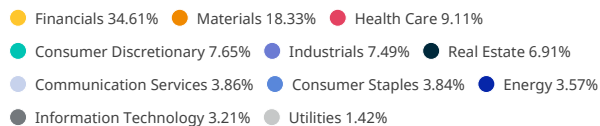
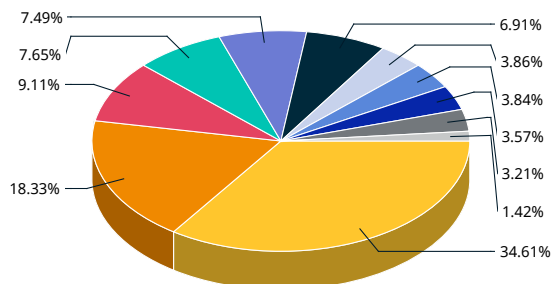
