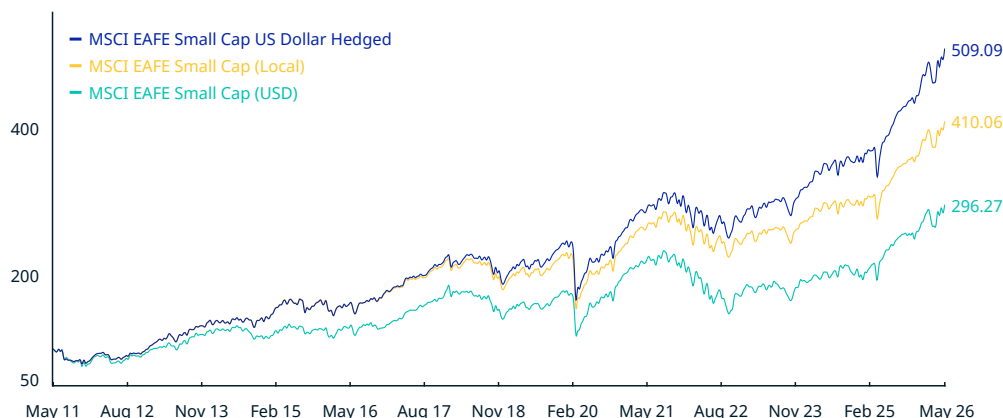


# MSCI EAFE Small Cap US Dollar Hedged Index (USD)

The **MSCI EAFE Small Cap US Dollar Hedged Index** represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI EAFE Index, to the USD, the "home" currency for the hedged index. The index is 100% hedged to the USD by selling each foreign currency forward at the one-month Forward rate. The parent index is composed of small cap stocks across 21 Developed Markets (DM) countries\* and its local performance is calculated in different currencies, including the Euro.

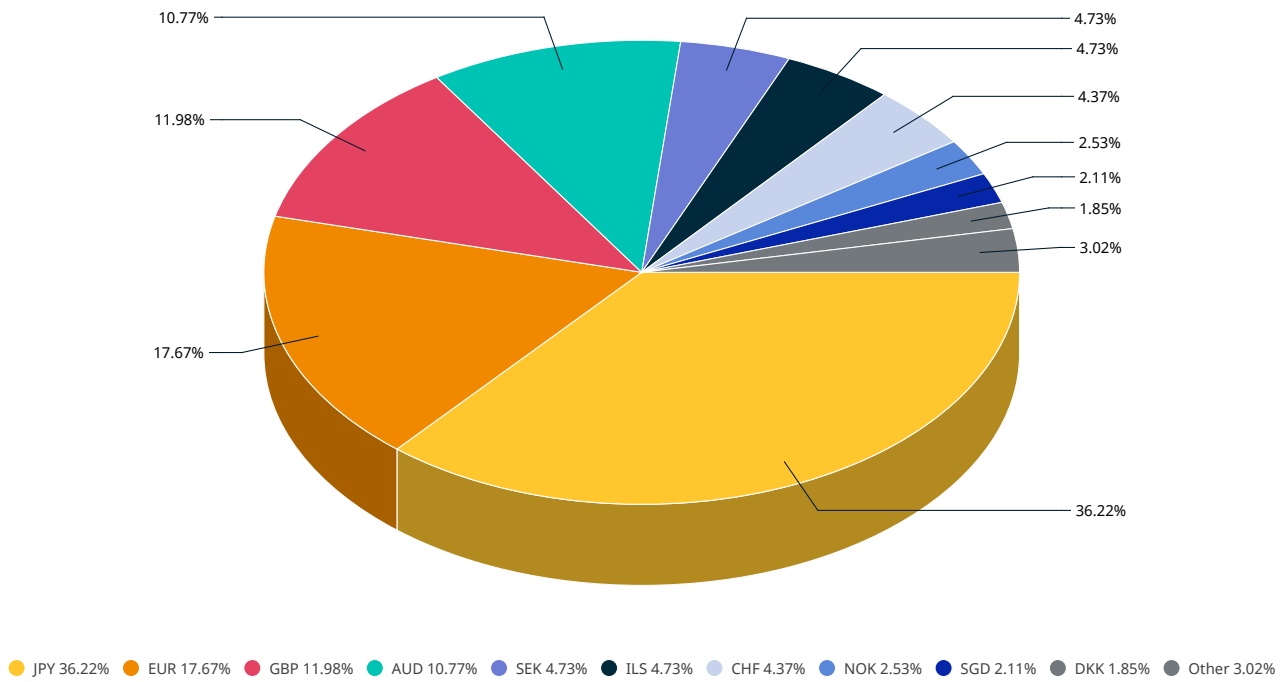
