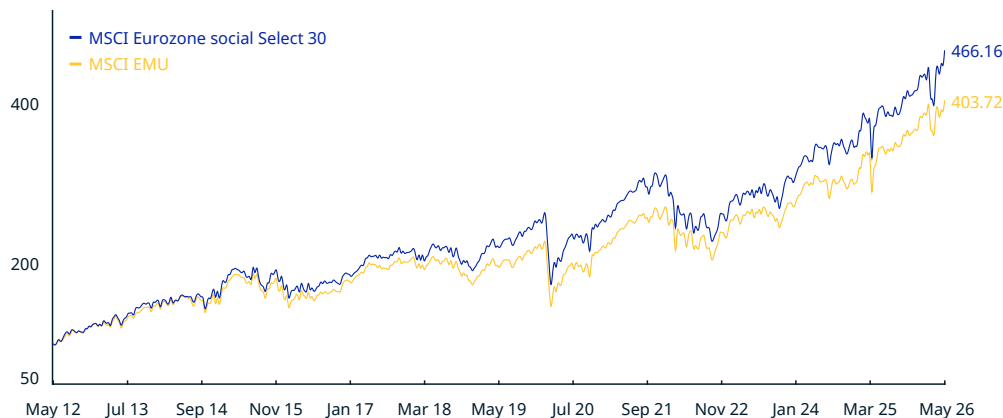


MSCI Eurozone social Select 30 Index (EUR)

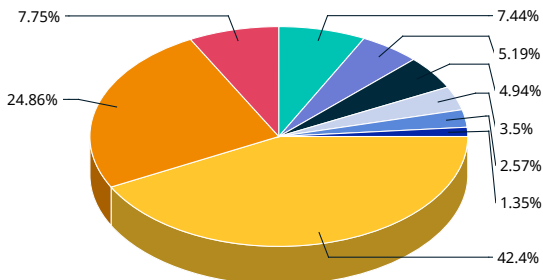

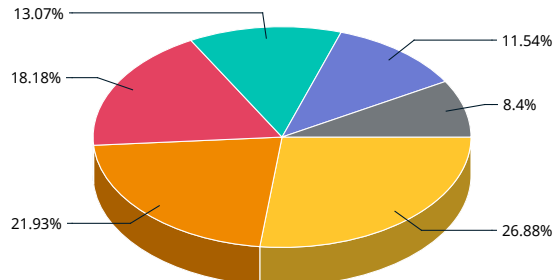
