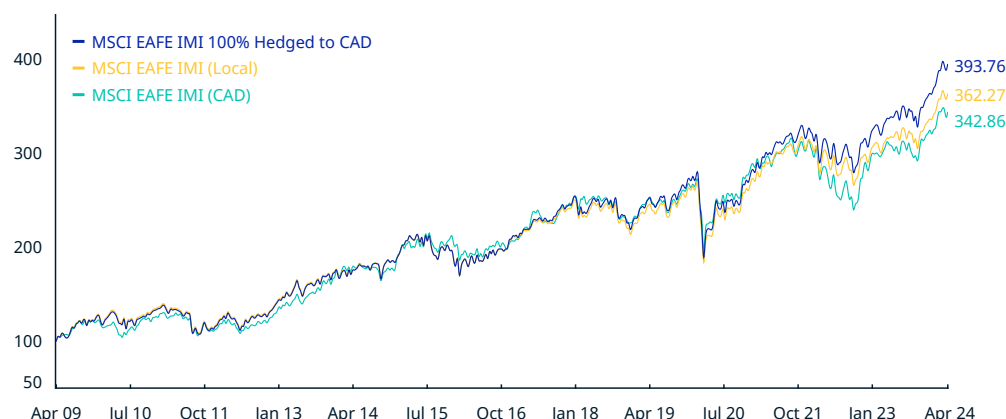


# MSCI EAFE IMI 100% Hedged to CAD Index (CAD)

The **MSCI EAFE Investable Market Index (IMI) 100% Hedged to CAD Index** represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI EAFE IMI, to the CAD, the "home" currency for the hedged index. The index is 100% hedged to the CAD by selling each foreign currency forward at the one-month Forward rate. The parent index is composed of large, mid and small cap stocks across 21 Developed Markets (DM) countries\* and its local performance is calculated in 13 different currencies, including the Euro.

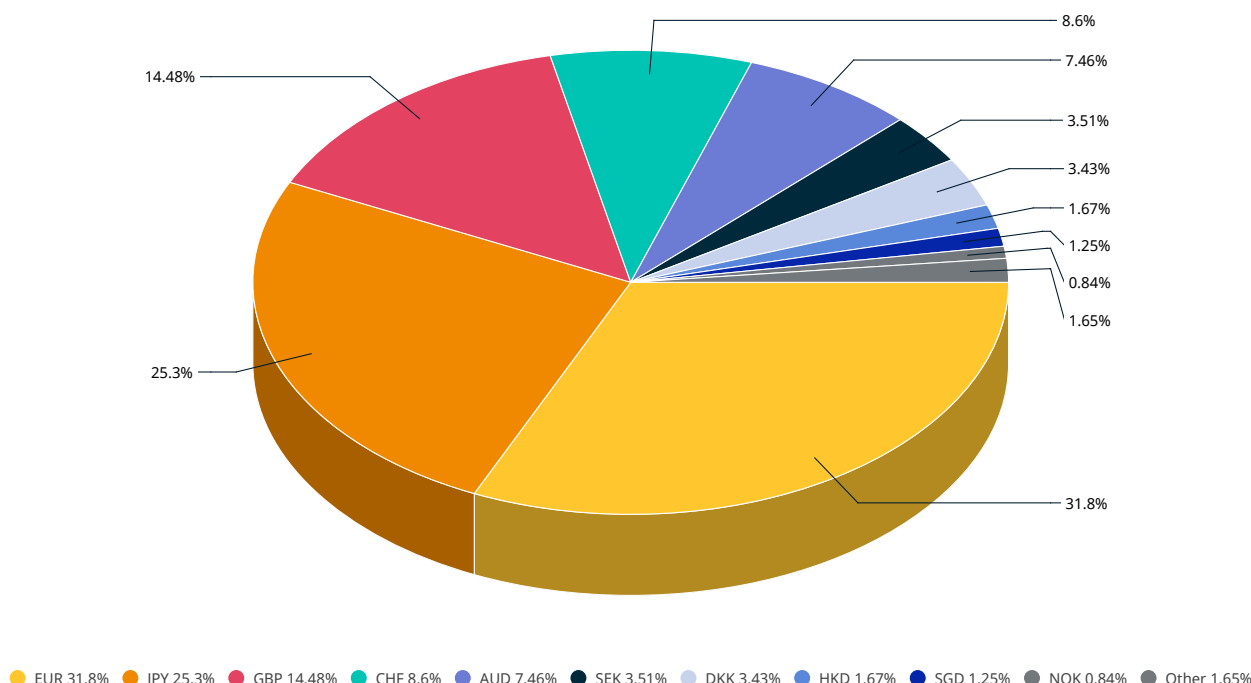
