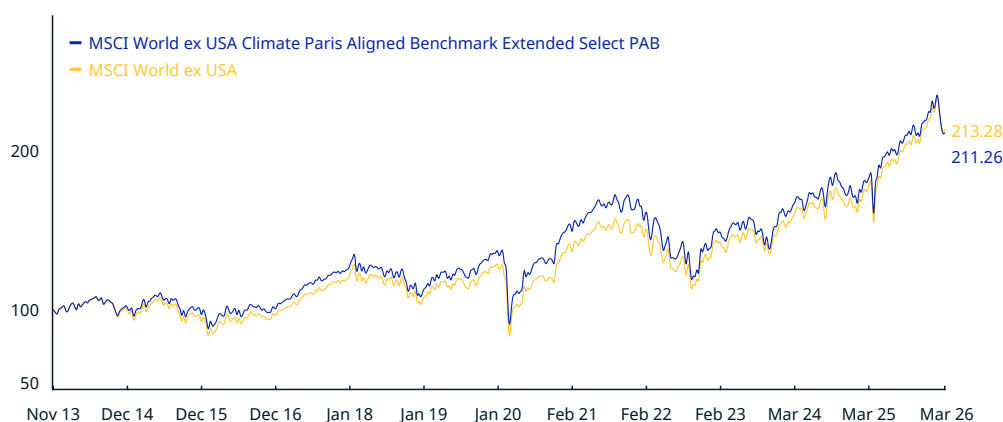


MSCI World ex USA Climate Paris Aligned Benchmark Extended Select PAB Index (USD)

The MSCI World ex USA Climate Paris Aligned Benchmark Extended Select PAB Index is based on the MSCI World ex USA Index, its parent index and includes large and mid-cap securities across 22 of 23 Developed Markets DM countries*- excluding the United States. The index is designed to minimize its exposure to transition and physical climate risks while targeting an alignment with the Paris Agreement requirements. The index is designed to exceed the minimum standards of the EU Paris Aligned Benchmark. Additionally, the index excludes companies from the parent index that are associated with controversial weapons, very severe Controversies, tobacco, environmental harm, thermal coal mining, Oil and Gas, Power Generation, Nuclear Weapons, Civilian Firearms, Oil Sands and missing ESG Rating.

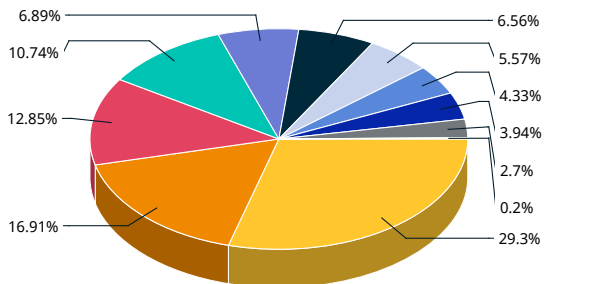

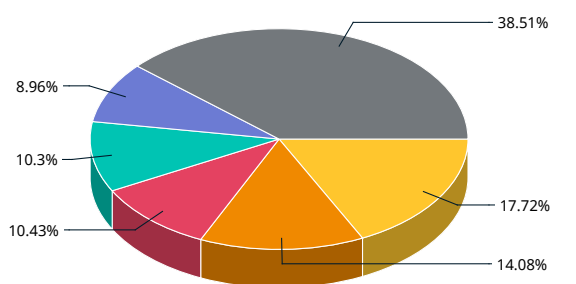
