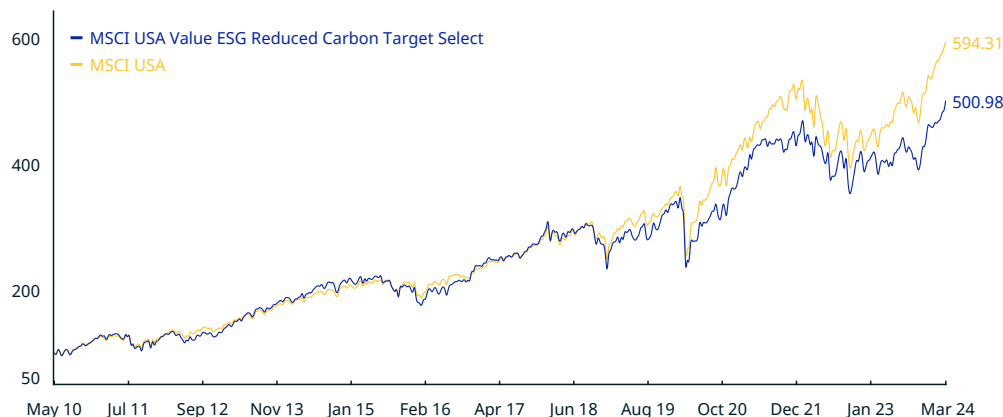


MSCI USA Value ESG Reduced Carbon Target Select Index (USD)

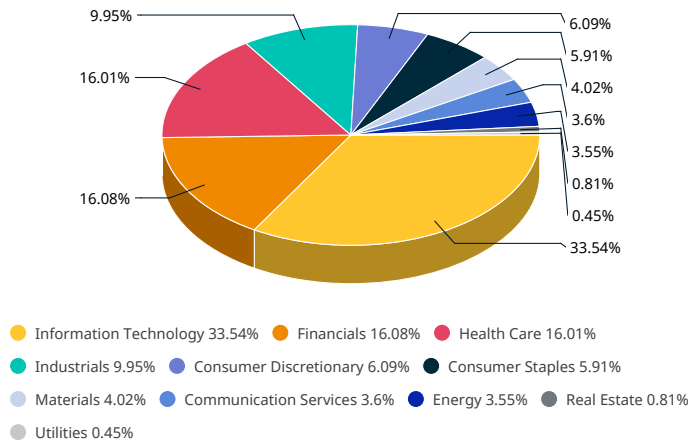
