

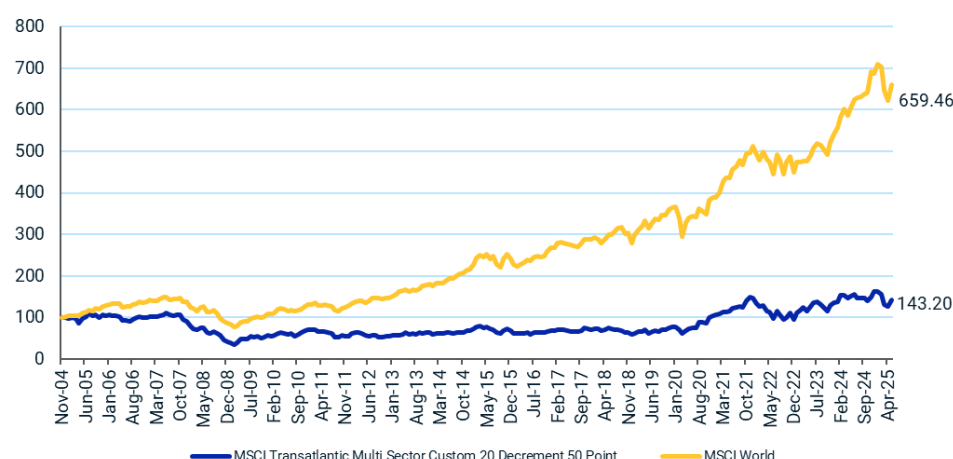
# MSCI Transatlantic Multi Sector Custom 20 Decrement 50 Point Index

The MSCI Transatlantic Multi Sector Custom 20 Decrement 50 Point Index aims to represent the performance of a strategy tracking MSCI Transatlantic Multi Sector Select 20 Index (the "Strategy Index") from which a pre-determined amount (a 'synthetic dividend'), as outlined under section 2, is withdrawn periodically. The index is constructed based on the MSCI Decrement Indexes Methodology.
