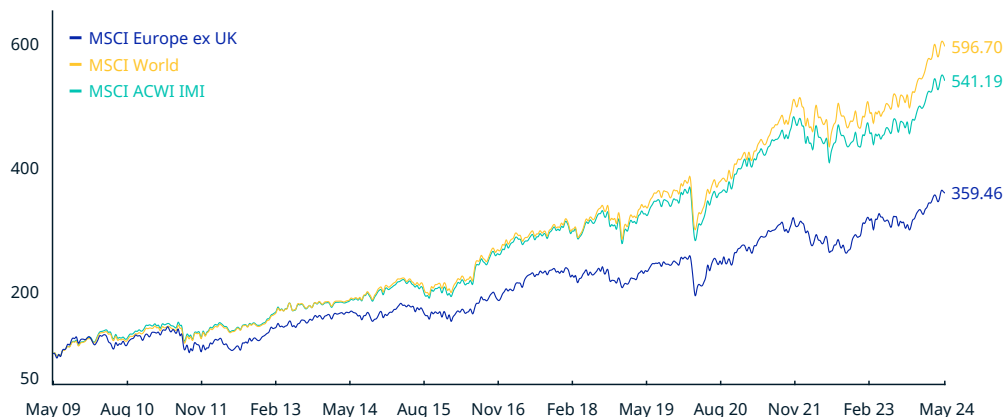


# MSCI Europe ex UK Index (GBP)

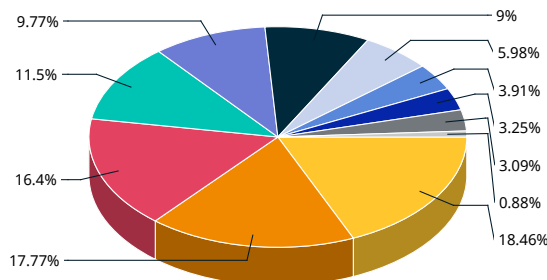

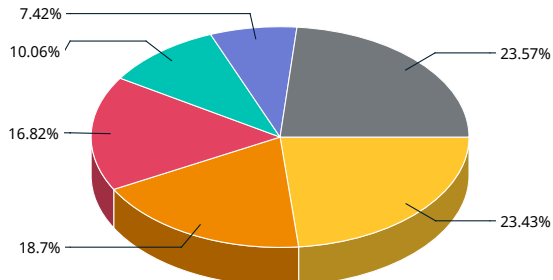
