Summary

MSCI Private Capital Closed-End Fund Indexes provide asset owners, asset managers, and General Partners with the most accurate insights into private capital returns, enabling unrivaled benchmarking of private capital funds and portfolios.

The 266 distinct indexes cover the spectrum of private capital asset classes, including private equity and venture capital, private debt, and private real assets—both globally and by region (see Appendix A for full index listing). As of Q1 2024, the indexes cover over 13,900 funds and funds of funds with a total capitalization of more than \$11.5 trillion.

Index Naming

The names of the MSCI Private Capital Closed-End Fund Indexes follow a defined formula such that the constituents and key calculation methodology for each index is clearly defined within the name of the index. The formula for the index names is as follows:

Component	Example	Definition
Geography ¹	Global	The geographical and/or development focus of the index constituents.
Asset Class ²	Venture Capital	The types of investments made by the fund constituents as defined by the type of entity (e.g. companies, properties), the age and/or operating condition of the entity (e.g. start-up, renovation), and the type of securities used (e.g. equity interests or debt interests).
Fund Structure	Closed-End Funds	The types of investment opportunities eligible to be a constituent of the index. Note: the MSCI Private Capital Closed-End Fund Indexes are all currently limited to closed-end fund vehicles.
History	Unfrozen	The nature of the index history as to whether historical changes are made to reflect newly available information (unfrozen) or whether historical data remains static (frozen). Note: the MSCI Private Capital Closed-End Fund Indexes are all currently unfrozen.
Currency	USD/EUR	The pooling currency for the calculation of quarterly returns and other index attributes.

Index Methodology


MSCI provides a wide variety of Private Capital Closed-End Fund Indexes which are governed by rules-based methodologies.

MSCI methodology documents outline index objectives and describe the rules and guidelines followed by MSCI to develop and maintain the MSCI Private Capital Closed-End Fund Indexes in the widest set of possible circumstances, including situations of market stress. MSCI's rules-based index methodologies are designed to ensure that indexes are determined with integrity, and that discretion with respect to methodology is only used in unusual cases not effectively addressed by the methodologies.

MSCI Private Capital Closed-End Fund Indexes are governed by the MSCI Private Capital Closed-End Fund Index Methodology document, the MSCI Private Capital Classification System and the MSCI Private Capital Closed-End Fund Index Policies.
